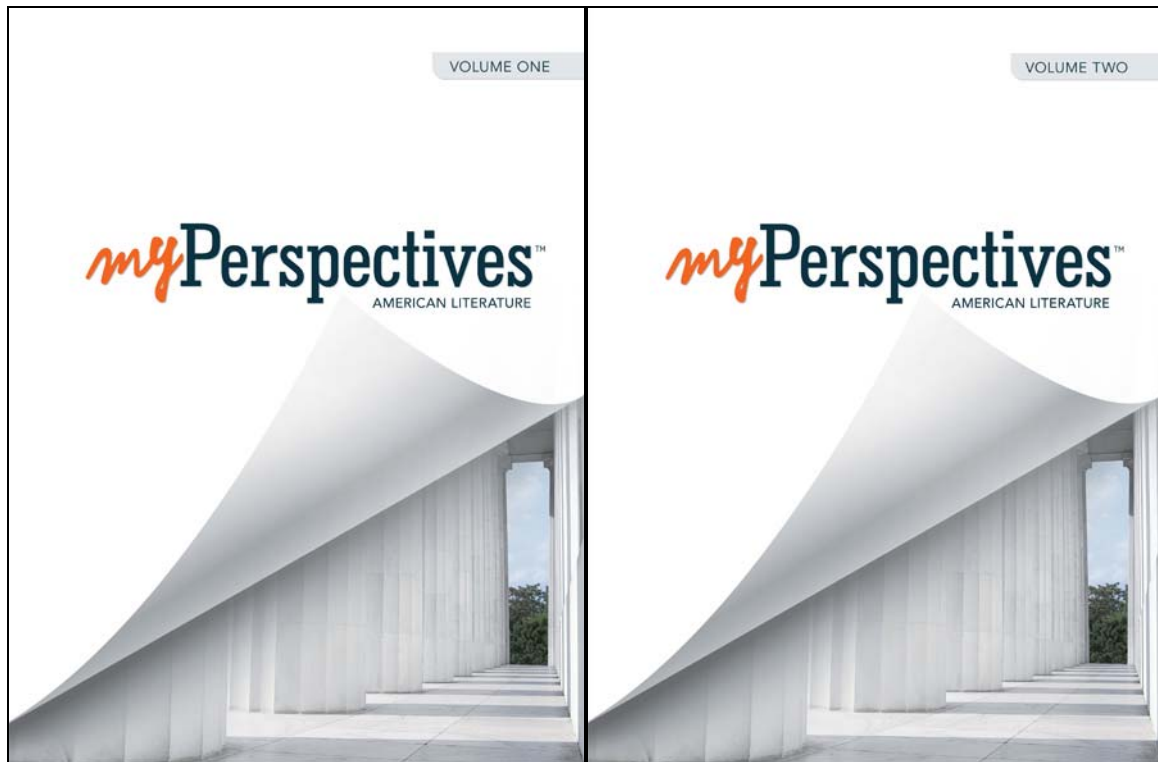

Additionally, this process looks at how an author’s rhetorical choices develop meaning or achieve a particular purpose or effect with a given audience.</p>	<p><i>myPerspectives</i> promotes student-centered learning through a unit organization that provide activities focus on making meaning. <p>Write for a variety of purposes. Students’ writing experiences in the course must exceed the timed writings that are assessed on the AP English Language and Composition Exam. For instance, students might undertake a lengthy and intensive inquiry into a problem or controversy, consulting and evaluating arguments and viewpoints presented in a variety of sources, and using those sources to provoke, complicate, and/or support their own responses to the problem or controversy. Students’ writing in the course should also go through a process that includes feedback from other readers, revision, and proofreading.
